## WHAT ARE SOME

**Wills/Bequests** — The simplest means of planned giving — you name our ministry as a beneficiary.

**Charitable Gift Annuities** — Annuities ensure you of both significant tax deductions and a fixed income for the rest of your life ... even as they help us minister to children, teens and adults.

**Deferred Gift Annuities** — Temporarily deferred, so you can make an irrevocable gift while receiving deductions for your higher income bracket. A good choice for those still some years from retirement, but who need deductions now — since principal and interest are compounded until payments begin.

**Revocable Charitable Trusts** — Ideal for those who want to be able to withdraw their investment at any time, without penalty. The benefit comes through an annual percentage of interest, which is subject to change and based on the amount invested.

## E OF MY OPTIONS?



**Charitable Remainder Unitrusts** — Irrevocable (though beneficiaries can be altered), you can avoid capital gains taxes while drawing a higher retirement income at a fixed annual rate of interest.

**Charitable Remainder Annuity Trusts** — Like unitrusts, except the fixed-dollar amount of your annual income is a percentage of original trust value.

**Charitable Lead Trusts** — Temporary placement of an asset in trust (with annual income going to the beneficiary), so you can retain ownership of the balance and enjoy tax deductions.

**Life Insurance** — Tax deductions are available for policies that name Montrose as beneficiary.

**IRAs/Pension Plan Gifts** — Giving these as charitable gifts frees you from both federal income and state taxes on the money, and enables us to receive other assets at a better tax rate.

**Personal Property/ Stocks/Bonds** — Can be given directly, or used as a basis for funding other kinds of planned gifts — like gift annuities, remainder unitrusts, and remainder annuity trusts. Deductions are based on property's and security's market value.

**Real Estate** — May be given outright, or with a stipulation for your continued use of the property, or sold as a bargain sale.

**Memorial** — A wonderful way to honor the memory of a loved one while supporting a project or ministry.
